He/She shall be governed by the Contributory Pension Rules prescribed under Notification No. 70/PEN/117/05 dated 18.05.2006 and guidelines issued vide Circular No. 166/PGIPF dated 22.07.2006.

He/she shall be on a probation period of 01 (one) year from the date of his/her joining.

Further, he/she shall draw a consolidated allowance of Rs. 7000/- per month only for the initial period of 1 (one) year of service as per Notification 489/GEN/DOP dated 31.10.2011.
